Allied Cooperative is offering a New Contracting Option for 2019

New Crop Average Pricing Program:

- Producer will enroll a set amount of bushels for new crop corn and/or soybeans to be delivered in October and November 2019.
- There will be ten pricing periods starting May 1, 2019 and ending on July 3, 2019.
- 1/10th of the enrolled bushels will be priced at the market close every Wednesday.
- No minimum bushel quantity.
- Free to enroll.
- Price-out option available at anytime during the pricing period. The cost to price-out will be 3 cents per bushel on remaining bushels. The final price will be the weighted average.
- Contracts can be a priced contract, or a hedge-to-arrive contract at completion of the pricing period. All hedge-to-arrive contracts must be indicated on the sign-up form.
- On priced contracts delivery location must be chosen during the enrollment period. Hedge-to-arrive contracts delivery location can be chosen at a later date when basis is established.

Deadline to sign-up bushels in average pricing program is **April 30, 2019**
